Executive Summary

JMN work marks a shift in the Indian human rights movement, which has been reluctant to address injustices in the name of caste as a fundamental human rights issue. JMN became one of only a handful of organization to declare that such discrimination goes against democratic principles by promoting inequality. With less economic resources, but rich with confidence and conviction, in a short period, its managed to amplify the voice of the marginalized in national and international fora.

JMN works to promote inclusion and basic rights no matter how complex it is, as he perceives them to be essential. It is driven by the knowledge that every life has intrinsic value and through championing the inclusion of disenfranchised people across India, JMN is fighting for the love for its country. It envisions India gaining strength through this remarkable diversity instead of being ripped apart.

COVID-19 made JMN more conscious about health of common people as it focuses on proper nutrition and boosting immunity. Organization initiated multidimensional support to communities, institutions and NGOs towards eliminating COVID-19 and providing awareness, vaccinations etc. JMN believes speaking up is a way of resilience for a community for sustainable development at the grassroots level. Healthy human resources and the elimination of barriers for the marginalised are one of the most important ways to strengthen the economy and boost the GDP. The negative conflict burdens the economy and so, positive resolutions and participatory pluralistic democracy lay the foundation for a sustainable economy of any country.

Humanitarian support to needy, breaking culture of silence & impunity, realization of SDGs and spirit of preamble of Indian Constitution are main focus for this year. COVID-19 had a debilitating effect on child survival, health, and nutrition due to the collapse of the economic machinery. Their woes have been exacerbated by cheap packaged foods such as crunchy, chips, and cream biscuits, which are high in salt and sugar. In the post- COVID period there is a double burden of malnutrition and non-communicable disease (NCD) susceptibility among marginalised children as a result of unregulated and ultra-processed packaged foods. With the aim of creating a healthier package through Front of Package

Labelling (FOPL), JMN organized several consultative sessions with various stakeholders in Uttar Pradesh, Telanagaand New Delhi to discuss childhood obesity, diabetes, and non-communicable diseases spiralling out of control due to excessive consumption of ultra-processed food and beverages during its first quarter. JMN in collaboration with many organization founded PIPAL (People's Initiative for Participatory Action on Food Labelling) as a national grassroots initiative to accelerate the adoption of strong food labels with the support of stakeholders.JanMitraNyas had meetings with pools of politician champion, Prime Minister, Commission and State Commission and State Governments. https://pipal.in.net/

Great Companies: What makes JanMitraNyas from hundreds of other similar service providers?

Lenin Raghuvanshi:

JanMitraNyas(JMN) is the symbol of non-violence resistance to millions of lower caste people known as Dalits fighting for their dignity in India. JMN is credited with changing the discourse on Dalit Politics in India and bringing into focus an innovative "people centric" approach based on justice, diversity, inclusiveness and pluralism to reclaim "human dignity" for the deprived sections in a caste ridden Indian society. The gamut of its activities reflects its ideological span and provides credibility and a sense of completeness to the work it does. Its care for details, meticulous planning, diligent patience, and sincere advocacy on the issues concerning the marginalized, has made millions of its supporters optimistic about a dignified future.

Great Companies: What were the struggles and challenges you faced and how did you overcome them?

Lenin Raghuvanshi: Trust of target communities was our first challenge. We developed tools of empathy and active listening along with continuous effort with patience. Financial difficulties and distrust of few sections of Government are also a challenge. Social audit and transparency of our account, clear vision, patriotism, courage with values of non-violence and impact based continuous works are a tools to overcome this.

Great Companies: How do you plan to grow in the future? What does 5 years down the line look like for JanMitraNyas?

Lenin Raghuvanshi: I am in phase of mentorship to create more professional for same vision and dream. Looking forward a vibrant and proactive process for a Global India for better world.

Great Companies: If you had one piece of advice to someone just starting out, what would it be?

Lenin Raghuvanshi: Making clear Vision, mission and goal based on SWOT analysis is one of most important process, but passion, courage and commitment are key for success and making millstone in any field.

OUR VISION

To establish a true, vibrant and fully entrenched democratic society through Jan Mitra concept where there shall be no violation of civil rights granted to a citizen by the state.

OUR MISSION

To provide basic rights to all, to eliminate situations, which give rise to exploitation of vulnerable and marginalized groups and to start a movement for a people friendly society (Jan Mitra Samaj) through an inter-institutional approach.

Working locations:Intensively in Eastern (Varanasi, Jaunpur, Sonbhadra, Allahabad, and Ambedkar Nagar) and western (Moradabad, Meerut, Badaun and Aligarh) regions of Uttar Pradesh and Koderma district of Jharkhand. Through networking working in 16 states of India with involvements of 99 organizations.

Working approach of the organisation:

- accurate investigation and documentation of human rights violations connected with advocacy, publication and networking on a local, national and international level
- Direct support and solidarity to marginalized and survivors in general and women, dalit, minorities, tribal, children in particular. Bringing learning of gap, challenges, and best practices for institutional reform against hegemonic masculinity.
- creating models of non -violent and democratic communities (People friendly villages, torture-free villages)
- building up local institutions and supporting them with active human rights networks
- creating a democratic structure for the 'voiceless' to enable them access to the constitutional guarantees of modern India in context of Universal Declaration OF Human Rights (UDHR)
- empowering marginalized communities through capacity building based on human dignity, hope, honour & justice process based organizational building and access to information
- promoting a human rights culture, and conflict transformation for sustainable peace based on pluralistic democracy, rule of law and participatory inclusive democracy

- linking local and international human rights together to support marginalized and survivors
- linking grass roots activities and international human rights networks and institutions

<u>Service Delivery – Programme</u>

The activities were implemented on the basis of the five comprehensive programsⁱ following the strategic plan of PVCHR/JMN

Comprehensive program for torture survivor

- Medical:Distribution of mask and sanitizer to survivors of the torture for preventing them from COVID – 19. JanMitraNyas with the support of the New Zealand High Commission provided nutritious diet to 2295 people (1925 children between age group 6 month to 5 years, 188 pregnant 137 lactating mothers, 20 survivors in Aligarh and 25 survivors in Varanasi) to boost their immunity to fight the deadly virus. 63 oxygen concentrators (with help of Indo-German Society of Remscheid, Germany & Embassy of New Zealand, India) were distributed in Uttar Pradesh. 24 oximeters were given to the staff for mapping the oxygen level. Sanitizer was distributed to the COVID survivors, Government hospitals and to the people of marginalized communities. 24 digital thermometers were given to the staffs for the body temperature of the people with whom they are working in the community and also of themselves. 30 oxygen masks were purchased 15 for children and 15 for adult. Oxygen masks are going to use for Oxygen Concentrators which distributed to PHC and CHC.
- 2. **Psychological:**The project provided psycho social support through testimonial therapy to the survivor 193 survivors (Male 84 and 109 female) who faced torture and ill treatment by the police force and Government officials during the time of COVID 19. The project not only provided psycho social support but also did multi layers and multi dimensional activities for providing justice to the survivors. Regarding the safety of the psycho social therapists and the survivors the project supported them with Masks and sanitizers. The centre was sanitized at

interval for the protection of the both and also well equipped to fight back COVID - 19. The project also provided the direct support i.e. medical support to the survivors having COVID symptoms. 121 survivors (70 Female and 51 Male) were supported through the testimonial therapy.



- 3. **Social:**21 folk schools and honor ceremonies organized in groups. In the ceremony 756 people (340 Male and 416 Female) participated. Following the COVID protocol 39 individual honor ceremonies were organized.
- 4. **Capacity Building:**Capacity building workshop for 65 local community leaders to enhance their knowledge on the helpline numbers and emergency services provided by the Government during the lockdown. The project honoured 200 community leaders (Aguwas) who tirelessly work or

supported at the grassroot level during the time of lock-down and also in unlock process for providing information to the organization or adjoining the survivor with the Government welfare schemes. 200 active community leaders were honoured with the certificate and cotton shawl.

5. **Livelihood initiative:**The project piloted the use of kitchen gardening, fruit garden and more oxygen



generating plants as the part of the healing process through increasing their participation and reintegrating back in the society. 15790 plants (64 plants of Mango, 720 peepal, 10 plants of lemon, 10 plants of pomegranate, 10 neem and 160 guavas). Seasonal vegetable seeds were distributed to 346 families. The beneficiary communities mostly belong to the marginalized communities in Varanasi district of Uttar Pradesh.

Legal:422 complaints were filed by directly intervening in a total 131 cases. The organization helped two types of victims, one directly who came to the office and on the other hand the cases of human rights abuses published in the newspaper. Financial compensation of INR 49,15,000 was awarded in 12 cases and legal action was taken against many guilty policemen. https://pvchr.blogspot.com/2022/01/compensation-awarded-in-year-2021.html

During Covid, 70 cases of domestic violence reported after providing counselling and writing letters the cases were referred to Rani Laxmi Bai, One Stop Center started by the Government to provide help to the destitute women and girls. The psycho – social therapist as expert therapist also provided voluntary in women cell working under the Uttar Pradesh Police. Activity: 1 Established the digitization system to archive the documentation Human rights violation cases and human rights situation and other reports.

The organization has done the following work for establishing the digitalization

- 1. Updated the website its website <u>www.pvchr.asia</u> through uploading all important documents and reports.
- 2. Created new website of JanMitraNyas<u>www.janmitranyas.in</u> with all legal compliances and <u>www.pipal.in.net</u> for rights of nutritional right of children, youth and adult.
- 3. Orient staffs on using Facebook, Instagram and twitter and zoom. Now JMN is using zoom for orientation and meeting of the project as well as board meeting and project review also.
- 4. The staffs are using google docs and WhatsApp for sharing the photos and documents.
- 5. The organization has created several blogs for project and initiatives and Facebook page.
- 6. Started petition at change.org online portal for advocating the issue of human rights. We received response from stakeholders on the petition.

Activity: 2 Training and knowledge update for organization staffs on HR principles update skills and tools.

Two workshops for the Training for on HR principal and Documentation of human Right Violation of organization staff were organized on 2nd October, 2021 and 14 October, 2021. In the workshop the participants were informed about the human rights act, mechanism and helpline numbers. The participants also learned about writing complaints, comments and impact stories. The participants also learned about human resources and institutional documents incorporated and followed by the organization as per the country law.



Activity: 3 Orientation to the grassroots level staffs regarding digitization system

JanMitraNyas has built the capacities of its key staffs on use for digitalization as cost effective tools for doing intervention in the cases of human rights for providing immediate remedy and justice. The workshop was organized

- 1. On 9 November, 2021 in Hotel Kamesh, Lahurabeer Varanasi. In the workshop the participants learned about doing intervention to NHRC on HRCNet Portal and complaints filed to concerned authorities through email. The participants also learned about use of social media such as facebook, twitter, instagram, blog and others for sharing the organization work as well as for doing intervention. In the workshop 39 people participated.
- 2. On 23 November, 2021 in PVCHR office in the training 19 people participated.

3. On 28th – 30th April, 2022 organized capacity building on digitization, youth manual and H.R Policy in PVCHR office. In the training 13 people participated.

Activity: 4 Strengthen the Gender and Inclusion policy and mechanism of the organization

The organization has developed its gender policy and organization manual incorporating gender in all sphere of organization work. The organization has strong internal complain committee (ICC) under Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) *Act*, 2013. *The organization at interval organized capacity building and refreshing training. The details of the committee are displayed in all prime location of the organization. Following law organization is organizing quarterly meeting and submitting annual meeting to District Magistrate as per the law. The organization has facilitated for the formation of ICC in other organization. Managing Trustee of the organization Ms. Shruti Nagvanshi is member of Internal Complain Committee (ICC) District Jail Varanasi and Committee on District supply. - **5.** Meeting held with former NOREC fellow for discussing on work they are doing. Mr. Bhanuja Saran, Director, Manav Sansadhan Evam Mahila Vikas Sansthan and Chairperson of CSO group of Niti Aayog and Lenin Raghuvanshi provided motivational talk.

- 2. Online Meeting with Viswa Yuwak Kendra for livelihood empowerment of youth on health services. 28 youth received three month training from Varanasi district.
- 3. On 11 February, 2022 connected with 51 youth through program organized in joint collaboration of Magadh University (https://www.magadhuniversity.ac.in/). The most participated are from Nalanda college (http://nalandacollegepup.com/).
- 4. On 7th April, 2022 on world health day Ms. Shruti Nagvanshi as guest of honor discussed about health, nutrition and front of packed labeling at Department of Social Work, Mahatma Gandhi Kashi Vidyapith, Varanasi.
- 5. Participated in the youth festival impression 2022 organized in Rudrakshacenter on 17th April, 2022. In the youth festival Dr. Lenin Raghuvanshi as chief guest presented on human rights, SDG and pluralism. In the festival more than thousand youth participated. Youth signed on flax demanding with Health Minister for strong and mandatory FOPL with warning label.
- 6. Fellows and other youth also signed on flax and it was sent to Health Minister of India.

<u>Women</u>

- 1. 2295 people (1925 children between age group 6 month to 5 years, 188 pregnant 137 lactating mothers , 20 survivors in Aligarh and 25 survivors in Varanasi) to boost their immunity to fight the deadly virus.ⁱⁱ Dry nutritious ration with high nutritional value (semolina, groundnut, Desi ghee, Soyabean and jaggery) was distributed to 188 pregnant and 137 lactating mother belonging to marginalized communities especially Musahar women in four blocks of Varanasi district and Muslim weaver community in Bazardiha of Varanasi district. The distribution was organized from 20 June, 2021 to 30 June, 2021.
- 2. Dry nutrition ration with high nutritional value (10 kg flour, 5 kg rice, 2 kg pulse, half litre oil and salt to each) to 25 survivors of domestic violence, gender-based violence and rape on 26 June, 2021 on International Day in support of torture survivor.
- 3. On 22 June, 2021 PVCHR Aligarh unit in joint collaboration of AMU non technical staff coordination Committee organized folk school for discussion on the COIVD protocol, vaccination and health. Following the discussion dry

nutritious ration was distributed to 20 COVID survivors with the hand of Prof. M.M.Sufyan Beg, Principal Zakir Husain College of Engineering and Technology (ZHCET) Aligarh Muslim University.

- 4. 600 sanitary packets were distributed to the woman and adolescence girl in 4 blocks and Bazardiha urban slum of Varanasi district. One packet includes 8 pads. It is a way to support for reproductive health in time of financial crisis in COVID time.
- 5. 500 N95 mask were printed with the logo of PVCHR and New Zealand High Commission New Delhi.
- 6. 29 oxygen concentrators were distributed to the PHC, CHC, district hospital, public charitable hospital in Uttar Pradesh. Dr. Ali Jafar Abedi, Health Officer and Assistant Professor, Aligarh Muslim University, Aligarh on occasion of handing over of two oxygen Concentrators, one nebulizer, four Oxy meters and thermometers to non-technical staffs' coordination committee, AMU
- 7. 24 oximeters were given to the staff for mapping the oxygen level of the people with whom they are working in the community and also of themselves.
- 8. Sanitizer was distributed to the COVID survivors, Government hospitals and to the people of marginalized communities.
- 9. 24 digital thermometers were given to the staffs for the body temperature of the people with whom they are working in the community and also of themselves.
- 10. Three nebulizers were purchased. One for Aligarh and 2 for CMC center in Pindra and Harhua.
- 11. 30 oxygen masks were purchased 15 for children and 15 for adult. Oxygen masks are going to use for Oxygen Concentrators which distributed to PHC and CHC.

Children:

- 1. 257 awareness programme and 9 open housesconducted in different part of Badaun for creating awareness on child protection, child labour and marriage and also informed about 1098. In the awareness program 7980 children and 13857 adults were covered.

- 1. 17 pregnant mothers were enrolled with PradhanmantriMatritwaVandan Yojana and 156 mothers with Janani Suraksha Yojana.
- 2. Three Additional Primary Health Center (ADPHC) and one Primary health center renovated and people from the target communities and area started to take benefits.



- 3. 27 new families linked with Public Distribution system. All total 2455 families are enrolled.
- 4. 335 families got work under MNREGA and they received wages of 676700 Rupees.
- 5. 96 weavers got weavers identity card and 38 weavers got benefits of Mudra loan.
- 6. Families linked with Kitchen Garden:Seeds of seasonal vegetable (Pumpkin, Bottle Gourd, Bitter Gourd and Beans) distributed to 1996 families of 38 villages. Mango, Pipal, lemon, neem and Guava plants was distributed.

Mobilizing collective voices for strong FoPL regulation to protect child and maternal health (1st September, 2021 to 30 April 2022)

1. Meeting held with 5 Union Minister of states (MoS), 17 Member of Parliament, 10 Member of Legislative Council and Assembly and 15 politicians. Two MoS sent the letter to Health Minister for demanding and mandatory FOPL interventions in India to protect public health.

With support from Campaign against Child Labour (CACL), Asha Trust and BunkarDastakarAdhikar Manch, the program was organized by People's Vigilance Committee on Human Rights (PVCHR), Foundation for Sustainable Development India, and Savitri Bai Phule Mahila Panchayat. During the program, Dr. Sangeeta Kansal, Professor & Head Department of Community Medicine, Institute of Medical Science BHU presented the Need for Nutrition Standard and FOPL in India to combat child obesity. Consumer Voice's COO, Ashim Sanyal, discusses the FOPL as an important policy instrument for civil rights and consumer protection.
